

APCTP Membership Agreement

This Agreement is entered into and effective as of March 24, 2020, of the signature by the Asia Pacific Center for Theoretical Physics, Pohang, Korea (hereinafter referred to as “APCTP”) and MATRIX, Melbourne, Australia (hereinafter referred to as “MATRIX”).

Article 1. Purpose

The purpose of this Agreement is to promote the cooperation between two involved parties in leading research in theoretical physics, facilitating international collaboration, and contributing to the advancement of physics in the Asia Pacific region.

Article 2. Objectives

The Agreement shall engage in the following objectives in order to achieve the purpose under Article 1 hereof:

- (1) To cooperate in joint research and academic activities in theoretical and mathematical physics;
- (2) To educate and train theoretical and mathematical physicists, in particular, young scientists;
- (3) To support all related research activities in theoretical and mathematical physics.

Article 3. Member Institute and Obligation

MATRIX agrees to remain a Member Institute of the APCTP on behalf of Australia and its physics community.

- (1) MATRIX as a Member Institute shall make best efforts to achieve the objectives under Article 2 hereof.
- (2) MATRIX shall contribute the fixed amount determined by the Board of Trustees. However, the membership due can be reduced by a decision by the Board of Trustees, with 2/3 or more of all Trustees voting in favour.

Article 4. Benefit

- (1) Scientists in member countries shall receive the benefits of APCTP activities with a higher priority within the limit of the APCTP budget.
- (2) MATRIX can advise the APCTP on the coordination of its cooperative activities with member countries.
- (3) If MATRIX fails to satisfy its obligation as a Member Institute for more than three years, the corresponding member country shall not be provided the benefit.

Article 5. Guidelines for Cooperation

The following general guidelines for cooperation will be observed under this Agreement.

- (1) Both parties reserve the inclusive right of the outcome of any performed research such as data, theses, reports, and any kind of material, and publishing, translating, or reprinting them in scientific or related journals.
- (2) Each of the parties agrees that it will not make use of, disseminate, or in any way disclose any important information of the other party to any person, institute, firm or business without mutual consent.
- (3) Any claims on the Intellectual Property Right under this Agreement shall be settled by amicable negotiation between both parties.

Article 6. Effect of Signature

- (1) Each party signing this Agreement intends that it shall take effect as an instrument under seal.
- (2) This Agreement is valid for three years.

Article 7. Revision

This Agreement may be modified by mutual consent, and the revised Agreement will be in effect from the date of signature.

Article 8. Termination

MATRIX can secede by notifying its intention to the Executive Director, or by a decision by the Board of Trustees, with 2/3 or more of all Trustees voting in favour.
