This Agreement is entered into and effective as of the date of signature by

Universitas Indonesia, a Legal-Entity State University based on Government Regulation Republic of Indonesia No. 75 Year 2021, domiciled at Jl. Salemba Raya 4, Jakarta; in this matter represented by **Prof. Dr. rer. nat. Abdul Haris** in his capacity as **Vice Rector for Academic and Student Affairs** pursuant to Rector of Universitas Indonesia Decree No. 1749/SK/R/UI/2020 and now therefore lawfully act for and of behalf of Universitas Indonesia (hereinafter referred to as “UI”)

and

The Asia Pacific Center for Theoretical Physics, Pohang, Korea, representing the theoretical physics communities of the Asia Pacific region, was established in Korea in June 1996, with **Professor C. N. Yang** as its founding **President**. As an international non-governmental organization in the field of theoretical physics, the Center aims to lead basic science in the Asia Pacific region (hereinafter referred to as “APCTP”).

Article 1. Purpose

This Agreement aims to promote the cooperation between the two parties in leading research in theoretical physics, facilitating international collaboration, and contributing to the advancement of physics in the Asia Pacific region.

Article 2. Objectives

The Agreement shall have the following objectives in order to achieve the purpose under Article 1 hereof:

- (1) To cooperate in joint research and academic activities in theoretical physics;
- (2) To educate and train physicists, in particular young scientists;
- (3) To support all related research activities in theoretical physics.

Article 3. Member Institute and Obligation

UI agrees to become a Member Institute of the APCTP on behalf of Indonesia and its physics community.

- (1) UI as a Member Institute shall exert its best efforts to achieve the objectives under Article 2 hereof.

- (2) UI shall contribute the fixed amount of the membership dues determined by the APCTP Board of Trustees. However, the membership dues can be adjusted by a decision by the APCTP Board of Trustees, with 2/3 or more of all Trustees voting in favour.

Article 4. Benefits

- (1) Scientists in member countries/regions shall receive the benefits of APCTP activities with a higher priority within the limit of APCTP budget.
- (2) UI can advise the APCTP on the coordination of its cooperative activities with member countries/regions.
- (3) If UI fails to satisfy its obligation as a Member Institute for more than three years, the corresponding Institute may not be provided the benefit.

Article 5. Guidelines for Cooperation

The following general guidelines for cooperation will be observed under this Agreement.

- (1) Both parties reserve the inclusive rights to the outcome of any performed research under this Agreement such as data, theses, reports, and any kind of material, and publishing, translating, or reprinting them in scientific or related journals.
- (2) Each of the parties agrees that it will not make use of, disseminate, or in any way disclose any important information of the other party to any person, institute, firm or business without mutual consent.
- (3) Any claims on the Intellectual Property Rights under this Agreement shall be settled by amicable negotiation between both parties.

Article 6. Effect of Signature

- (1) Each party signing this Agreement intends that it shall take effect as an instrument under seal.
- (2) This Agreement is valid for three years and will be automatically renewed for successive three-year periods unless either party gives six months' advance notice in writing to terminate the Agreement.


Article 7. Revision

This Agreement may be modified by mutual consent, and the revised Agreement will be in effect from the date of signature.

Article 8. Termination

UI can withdraw from membership by notifying its intention to the Executive Director, or by a decision by the APCTP Board of Trustees, with 2/3 or more of all Trustees voting in favour. 
